Query 6: Do we endeavor by example and precept to cultivate in our children a sense of openness and expectancy about life, and to aid them in their growth in spiritual understanding and moral discernment? Do we share with them the faith that guides the practice of Friends, while encouraging them to develop their religious insights as the Spirit of God may lead them?

We acknowledge that in our present circumstances we are limited in what we can offer our children. Child care for the youngest seems to be our role as a meeting. The query suggests, rightly, that parents provide spiritual nurture and education for their children and we see evidence that our children are receiving guidance from their families. We encourage children who are able to sit through meeting to do so.

We ask ourselves what is this meeting called to do? How do we provide a breadth and depth of knowledge of Quakerism to the parents in our meeting?

Our children are our hope for a world without war and we pray that a peaceful world will be the future for our children.

Our letter to our young people encouraging them in their conscientious objection to war and assuring them of meeting support was received gratefully.

Ray Treadway presented the **Treasurer's Report** for Fifth Month which was accepted. The complete report is attached to the minutes; a summary follows:

From our contingency fund, the Meeting responded to a request from Catholic Social Services to assist a client for

\$100, sent \$100 as a token of appreciation to New Garden Friends Meeting, and spent \$62.09 for refreshments at the memorial service.

Income to the general fund for the first five months of the budget year has been \$7,984 compared to a prorated amount of \$9,671 needed to meet the meeting's budget for the year.

Representative to the Yearly Meeting Nominating Committee

Nan Bowles was named as yearly meeting Nominating Committee member from Friendship Meeting. It was noted that there is no stated procedure for naming the monthly meeting member of the yearly meeting Nominating Committee and that the Friendship Nominating Committee undertook this responsibility by default. Hereafter the Nominating Committee will routinely suggest names for the yearly meeting Nominating Committee.

Committee Clerks and the Handbook

Claire Koster brought a concern to the meeting that since not all committee clerks have been named pending the decisions of the committees at their first meeting in Eighth month, these names will not be available for inclusion in the meeting handbook due out in Eighth month. In view of this difficulty, Friends agreed to move the handbook report to Ninth month.

State of the Meeting Report

The clerk presented the State of the Meeting report for yearly meeting which was accepted with minor corrections. The report is subject to further amendment following the called meeting on Sixth month 17th. The report is as follows:

**Friendship Monthly Meeting
of the Religious Society of Friends**

Report of the State of the Meeting, 2006/2007
While carrying on all the usual activities of a settled meeting over the past year, members and attenders at Friendship Meeting have felt a growing awareness of being in transition. Challenged last spring by the City of Greensboro to reduce the impermeable surface on our property, we have come to realize that even a technical solution solving the immediate problem of water runoff would leave us unable to meet the needs of our growing membership. By late spring we had reached unity in understanding that our days at our

present location are probably numbered; still facing us are the questions of where we will find a new home and how we will make the change happen. The possibility that has so far seemed the most attractive is to build a new meetinghouse on the Guilford College campus. By fall, we should know whether there is a true community of interest that would move that project forward to reality.

Major decisions about property are always challenging to a meeting: Can we reach unity on our needs? Having loved our current home despite its limitations, can we reconcile ourselves to its becoming a memory? If we sell our present property, where can we find another that would serve us better but that we could afford? If we move to the Guilford campus, how can we maintain ourselves as both an autonomous meeting and a strong presence at the college and school? Friends have struggled with these questions through two threshing sessions, an all-meeting retreat, and countless other meetings and conversations. This process required us to move back a step at our retreat, to discern together our calling as a meeting. From that exercise emerged a clear sense that our core identity as a meeting is as part of the community of Quaker institutions at the intersection of Friendly Avenue and New Garden Road. While outreach and witness beyond our suburban enclave are important, we will continue to nurture and be fed in turn by our neighbors at Guilford College, New Garden Friends School, Friends Homes, and New Garden Meeting. From this perspective, a meetinghouse on the college campus could be a physical focus for strengthening the community of these institutions.

Meanwhile, we continue with the ordinary business of a Friends meeting. At the core is always our worship. Our weekly meetings are regularly blessed with the movement of the Spirit in our midst, whether revealed through a striking thread of vocal ministry or simply permeating the silence. The worship sharing at our retreat helped us articulate once again how much we rely on the shared, corporate search for Truth, no matter the particular language in which we may express our findings. Our mid-week worship, held at Friends Homes, continues to nurture those who can no longer make it to the meetinghouse on First Days.

One measure of our spiritual health is our growth. Our membership, which broke 100 for the first time little more than a year ago, now stands at 120. Some of this growth comes from those newly arriving in the area, some from transfers of long-time attenders who have finally felt sufficiently settled to give up old ties to cement their relationship to their current community. This spring we admitted two members new to the Society of Friends who bring to us important new spiritual gifts. Many of our attenders and visitors come seeking the spiritual depth of Conservative Quakerism.

Another source of growth has been our renewed ability

to serve families with children. While we are still experimenting with ways to serve the needs for a range of ages, we have been enriched by the growing number of children among us. So far, our largest cohort is of pre-schoolers, with one or two pre-teens, and a few high schoolers. Intergenerational forums geared especially to the needs and interests of our older youth brought out far more seniors than young Friends; they will continue on a more ad hoc, occasional basis than the monthly pattern originally envisioned. We are blessed by the care of members supporting the Religious Education Committee and of the Guilford students who have provided a consistent presence for our junior meeting.

Our members remain active in the wider Quaker world. Friendship Friends have rendered important service to the Friends World Committee for Consultation, Piedmont Friends Fellowship, Friends General Conference, Friends Committee on National Legislation, Pendle Hill, Quaker House, the School of the Spirit, and Friends for Lesbian, Gay, Bisexual, Transgender, and Queer Concerns. At the moment, we provide the presiding clerk, recording clerk, and treasurer for our yearly meeting, and others provide a substantial active base for our closest Friends fellowship.

Friends also continue to carry their witness into the world, both individually and as a meeting. Friends carry their commitment to peace and justice into their professional and volunteer lives. In August, our Worship and Ministry Committee sponsored a forum with Chuck Fager on his *Friends Journal* essay, "Survival and Resistance," with the conversation continued over lunch at a member's home. We endorsed (with minor modifications) New Garden Meeting's minute on torture, and continue to work closely with People of Faith Against the Death Penalty and Quaker House. In March our member Judy Heitfield presented an intergenerational forum on the Children's Creative Response to Conflict that grew out of the work of New York Yearly Meeting. Our Care and Counsel Committee drafted a letter sent over the meeting clerk's signature to all you young Friends offering assistance as they confront the issue of the military draft. We continue to provide hospitality to the local Parents and Friends of Lesbians and Gays.

This winter our Peace and Social Concerns Committee felt called to provide a sustained focus on local social justice issues and especially the needs of our immigrant community. This focus has guided many of the committee's discretionary donations and the choice of forums: member Darlene Stanley discussing the range of social services available in the community; a staff member of the United Food and Commercial Workers Union describing the organizing campaigns at the Smithfield Products Tarboro plant; and Mark Sills of FaithAction International providing an overview of

Greensboro's immigrant community.

The same rhythm of continuity and transition that the meeting has felt this year can be seen in the lives of our members. On the joyful side, we celebrated the marriage of our sojourning member Beyond Joy and Elizabeth Campbell Laird in a Celtic-flavored event on September 23rd. Attenders Rick Bohanan and Anna Mercedes welcomed Sylva Mercedes Bohanan into their family. Edith Mackie celebrated her 101st birthday on March 24th. More difficult for us to celebrate is the loss of long-time members to illness and death. Adrienne Dahlke died on October 19th, ending a long life marked by keen intelligence and sweetness of spirit. The sudden death on May 3rd of Caroline McHardy Elliot, wife of member David Bailey, from Rocky Mountain spotted fever leaves us in shock. We remember the many events of in the lives of our members — graduations, births of grandchildren, illness and death of loved ones — and continue to hold in our prayers all those dealing with transitions, joyful and otherwise.

This year, the Meeting has had the sense of starting out on a new journey, with several side trips. Our hope for the coming months is that we shall find clarity in our direction as we face the future. Above all, we are keenly aware that truth and unity will emerge from a process of discernment centered in worship and undertaken in love.

Membership Report

Claire Koster presented the membership report which was accepted with appreciation and is also subject to amendment after the called meeting of 6 Month 17th.

Query Answers

The answers to the Queries approved by Worship and Ministry were considered and approved with minor changes. The Sixth month query answers will be included.

House and Grounds Annual Report

Carey Reece read the annual report of the House and Grounds Committee which was accepted. It should be noted that the report was completed in Fourth month and was delayed in transmission. Some parts of the report have been affected by subsequent events.

House and Grounds Monthly Report

After an extended consideration of a proposed design for a new meetinghouse sign, unity was not reached. The matter was referred back to House and Grounds. There was unity that a replacement of the sign without significant changes does not need the approval of the meeting but that other proposed changes would need to be approved by the meeting.

Appreciation for the Clerk's Service

The meeting expressed profound gratitude for the clerk's service for the last three years.

Conclusion

There being no further business, the meeting concluded purposing to reconvene on the Twelfth of Eighth month if consistent with divine will.
