Tenth Month Meeting for Worship with an attention to Business

The clerk read our response from the Ninth query, which was approved with no amendments. Query 9: Are we mindful of Friends testimonies against alcoholic beverages, tobacco, and other harmful drugs; and do we refrain from using them or dealing in them, realizing that abstinence is the clearest witness against overindulgence? Do we seek to avoid all kinds of gambling and places of diversion that tend to be demoralizing? Do we keep in mind how diverse and widespread are the temptations to grow richer at the expense of others? Are we faithful to our testimony against taking oaths?

There are times when the needs of a minority group must be acknowledged by the larger community, as with food allergies and dietary restrictions. Friends who must abstain from alcohol and other harmful drugs as a matter of personal necessity are happy to be able to depend on this Meeting as a safe space.

This query covers a wide variety of seemingly disparate, specific topics, and it is hard to address them all together. Some Friends have particular problems with the part about not taking oaths. Some question the continuing relevance of this prohibition, though it remains a useful lens through which to make a statement about our truth testimony.

Are we aware of the extent to which our media environment can be demoralizing and even addictive? Conventional wisdom can make certain activities, such as investing, seem normal, but these financial transactions can be a form of addiction, and it is hard to know who is harmed by one's investments.

If we want to address the addiction in the lives of others, we also need to be aware of the larger contexts of people's lives that may create the conditions for addiction.

Ray Treadway presented the treasurer's report, which was accepted with gratitude. The complete report is attached; a summary follows:

Expenses of note during the month: printing and mailing the handbook – \$70.30, newsletter and postage – \$24.81; sandwiches for Urban Ministry (six months) – \$227.41; supplies and miscellaneous – \$62.01, our regular donation to Quaker House of Fayetteville for operating expenses –\$100; Friends Center at Guilford College – \$600.00, Friends Historical Collection – \$300, Guilford College – \$150, electricity – \$100.86; gas – \$10.00; maintenance – \$45.79, and telephone – \$62.05, and water/sewer – \$14.25. The Meeting received two contributions to the property fund for \$150.00.

For the year (nine months) we have received \$11,980 to the general fund in donations, which is about 52% of our total budget. Contributions to the general fund and to our special funds would be appreciated. Checks can be made out to Friendship Friends Meeting and sent to POB 8652, Greensboro NC 27419 or left in the contributions basket on the table in the gathering room.

Neil Swenson reported on behalf of the Nominating Committee that Priscilla Zuck has stepped aside as calendar coordinator, and Sid Kitchens was nominated to take over this position until the next nominating cycle.

Friends approved.

Cary Reece reported on behalf of House and Grounds that this committee is investigating alternatives to our current telephone service.

Judy Reece on behalf of the welcoming committee for Don Smith (Gay Bowles, Mae Brown, and Judy Reece) reported that the welcoming party for Don Smith on Tenth Month the Eighth was enjoyed by all, and experimentally demonstrated the structural integrity of the new deck.

The meeting closed with a few moments of silent worship.

Reducing Personal Junk Mail

Contact the <u>Direct Marketing Association</u> to be removed from many companies' mass marketing mailing lists for up to five years.

<u>Catalog Choice</u> provides information on common mailings (along with a free service to help you opt-out of mailings).

Contact <u>Val-Pak Coupons</u> directly to ask to be removed from their mailing list.

To stop delivery of yellow pages, enter your zip code at <u>Catalog Choice</u> to see contact information for all local yellow pages. Also, you can now opt out online from receiving your local AT&T Yellow Pages.

Every loose-leaf bundle of business or supermarket fliers must be delivered along with an address postcard which provides contact information for opting out. If the bulk mail comes through Valassis, you can also <a href="https://example.com/opt-out/opt-o

To stop receiving unsolicited credit card and other credit related offers, opt out permanently at www.optoutprescreeen.com. Learn more via the Federal Trade Commission.

Your credit card company probably sells your name the most often. Call and ask them to stop. Also make the same request of your bank and any other companies from which you purchase products or services on a regular basis (for example, companies who sell you magazines, phone service, and gas & electric services).

Create a place to store all unwanted mail. Once a month, call the local or toll-free numbers on the mailings and ask to be removed from their mailing lists (toll-free area codes are 800, 888, 877, or 866). This is the most effective way to get off mailing lists. If there isn't a local or toll-free number but there is a postage-paid return envelope, tear off the mailing label and enclose it in the envelope along with a request to be removed from their mailing list. Mark envelope "ATTN: Customer Service". Another option: write "refused" or "refused: return to sender" across the address, cross out the bar code. and drop in any mailbox. If it is 'First Class' mail, it will be returned to the sender. If it is 'Presorted Standard' (third class) mail, there is an 80% chance that you will be taken off the senders mailing list. Product warranty

cards are often used to collect information on your habits and income, for the sole purpose of targeting direct mail. They are not required in most situations - avoid sending them.

Avoid filling out "Contest" cards – these are almost always fishing expeditions for names.

Whenever you donate money or order a product or service, write in large letters: "Please do not sell my name or address". Most organizations will properly mark your name in their computer.
