#### Month's Query

Query #1 Do we faithfully uphold our testimony for worship which is based on silent waiting, and for a free and unprogrammed ministry that may be shared by all? Is there a living silence in which we feel drawn together by the Light of Christ, the power of God in our midst; and is this inspiration carried over into our daily lives? Do we come to meeting with hearts and minds open and ready to worship in silence or in vocal ministry or prayer as the Holy Spirit leads us? Does our Meeting encourage those who may have a gift in the spoken ministry?

Reading: We have found that in offering programs and workshops it is helpful to have someone paying attention to the eldering function. Helping create a vessel that includes everyone and God, love and trust. This sometimes is simply sitting, worshipping and praying, holding the body in the Light, being a spiritual presence. Paying attention to the deeper stuff. Sometimes we call this the "person of Presence," and s/he also takes care of the mundane hospitality issues of the leaders and participants. Sometimes this elder is invited to reflect formally on what s/he saw of the movement of the Spirit throughout the session. This has been called "a minute of exercise" in other times. ### **Annual Report of Worship and Ministry**

December, 2017

The responsibility of Worship and Ministry is to foster the spiritual life of the Meeting. In particular, the committee attends to the spiritual quality of the meeting for worship and the meeting for business. We take time in each of our meetings to consider how these two gatherings have been going and to work with the clerk of the meeting to address issues or explore ways to sustain and nurture a strong spiritual base.

Our responsibility includes encouraging those with gifts in ministry, whether spoken or otherwise. We have helped Deborah Shaw redevelop a support committee for her ministry, we receive reports from Lloyd Lee Wilson's committee, and we helped to form anchor committees for two members involved in the Deeper Roots program. We continue to look for other ways, formal and informal, to encourage well-grounded ministry in meeting.

In June, we gave Bibles to the older children of First Day School and books of Bible stories to our younger children. We led a retreat based on The Rooms of the Meetinghouse: meeting participants were invited to enter the various spaces in and around our meetinghouse and to consider how they might look to visitors and how they convey aspects of our corporate life. We sponsored a welcome tea for new members of the meeting, offering an opportunity to hear about the history of the

meeting and its context in North Carolina Yearly Meeting. We sponsored a forum featuring the music of Paulette Meier, which was well received by our children and adults. While we will not be coordinating the Christmas Eve service at Friends Homes this year (due to scheduling conflicts) we look forward to continuing this tradition in 2018.

With Care and Counsel, we provide a Designated Friend who is available after meeting for worship to answer questions about the meeting or Friends beliefs and practice, and we meet with that committee to answer the Yearly Meeting queries and share other concerns. Once a month a member of W&M closes meeting for worship, and a member reads a portion of the NCYM-C Advices in meeting for business. In preparation for NCYM-C annual sessions, we answer the queries for worship and ministry committees.

In September, Judy Purvis agreed to clerk the committee. We expressed our deep gratitude to Darlene Stanley, whose clerking over the last several years has kept the committee well grounded and responsive to the ongoing spiritual needs of the meeting. Deborah Shaw rejoined our committee after a year's sabbatical.

The spiritual health of our meeting is an ongoing concern. Since we are all ministers in our own way, we on Worship and Ministry encourage all meeting participants

to share their concerns, questions, and suggestions with us to keep our meeting strong and spiritually deep.

# Treasurer's Report: Eleventh Month 2017 Income and Expenses

Income in November 2017 totaled \$4,629.15 with \$1,930.00 to the General Fund and \$2,504.68 to the New Building Fund and \$194.47 to the Property Fund from a sales tax refund.

Expenses in November 2017 totaled \$770.41. General Fund expenses totaled \$546.41 which included: Operating Expenses of \$202.00 primarily for supplies; no Supporting Contributions; and Meeting House Expenses of \$344.41 primarily for utilities and for deed work. The Young Friends Fund had expenses of \$224.00 disbursing funds raised this summer.

Stephen Holland presented the proposed monthly meeting budget for 2018: The same budget labeled "Budget 1 - 2018" in the report presented last month: Friends approved this budget after amending the Quaker House donation to \$600.

<u>Closing Minute</u>. No further business appearing, and hearts and minds being generally clear, Friends adjourned, purposing to meet again at the appointed time in First Month, if consistent with divine will.
